Research and Teaching Interests

I am a rhetorical studies scholar devoted to the study of how our symbolic actions ranging from social movement discourse to scientific models in biomedical research reflect, index, and enact values, whether those be the values of power and money or the values of community and care. Specifically, through a variety of publications including journal articles and single-authored and co-edited books, I have explored how socially constructed and normative ideas about race and gender influence biomedical research; what the exercise of "biocitizenship" looks like when we have to ground our claims on the state in embodied experience; the influence of capitalist interests on the conceptual practices of scientists; and how utopian longing can materialize as concrete symbolic action in the world, bringing about social relations not structured by capitalist logics (for example, by inventing speculative imaginaries that depart from those structured by the likes of finance capital for which only some futures matter). This work together asks after not only how it is that certain social relations are reproduced over time but how novel and innovative political practice—broadly construed to include art and literature—can provide the tools necessary for social change in a world in which such change becomes increasingly difficult to perceive, visualize, and enact. Throughout my work I show the abiding importance in the humanities, especially at a time when solutions to problems are narrowly defined in technological/instrumentalist terms and when theory is dismissed as

the privilege of academics disconnected from the "real" world. Only the humanities, I show, can identify and explain the creative, innovative, and disruptive articulations of other ways of being in the world, free as they are from the constraints of the sciences (and to an extent, the social sciences) obliged to explain the world as it is and in ways that divorce us from the unfulfilled promises of past struggles.

I teach courses in rhetorical theory, feminist theory, social movements, queer theory, capitalism studies, and science and society. Specifically, I have taught the following courses while at UGA:
